

**THE HARBORMAGIC.COM MONTHLY “WIN A GETAWAY”
SWEEPSTAKES - OFFICIAL RULES**

A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

The HARBORMAGIC.COM MONTHLY “WIN A GETAWAY” SWEEPSTAKES (the "Sweepstakes"), starts in October 2005 and drawings will be held monthly, unless terminated earlier for any reason. The Sponsor of this Sweepstakes is Harbor Magic Hotels, 711 Eastern Avenue, Baltimore MD 21202 ("Sponsor").

ELIGIBILITY: Sweepstakes is open only to legal residents of the United States, 18 years of age or older (except residents of Florida, Puerto Rico and all U.S. territories and possessions and where prohibited by law). Employees of Meyer Jabara Hotels and its affiliates, agencies, and participating retailers are not eligible to participate nor are immediate family members of such employees. Only one entry per day is permitted for the same email address. All entries will remain in the database of entries for the duration of the sweepstakes. Odds of winning a prize are determined by the total number of eligible entries received for the Sweepstakes.

PRIZES: Sweepstakes drawings will be held on the first day of each month. There will be one first place winner of an overnight getaway at one of the Harbor Magic Hotels.

Grand Prize Winner will be contacted by Sponsor’s representative upon winning the prize. A certificate for an overnight stay in one of the Harbor Magic Hotels – Pier 5 Hotel, Admiral Fell Inn or Brookshire Suites - will be awarded to the winner.

Certificates must be used within one year of drawing and are not redeemable for cash. Getaways are subject to availability at the time of reservation. Winner will be responsible for all taxes (federal, state, local and/or income) and all expenses not listed related to acceptance and use of any portion of the prize including, but not limited to, travel expenses and other expenses incurred while on the Harbor Magic Getaway. All Prize winners will be notified via email or standard mail and winner will be required to execute and return an Affidavit of Eligibility/Release of Liability form, and (except where prohibited) a Publicity Release and a completed IRS W-9 form within 14 days of date of notification. Failure to return all required documents in this time period might result in the winner being disqualified and an alternate winner selected.
